## PGP / PGO /M.Sc.(SLP)/M.Sc.(Audio)/ M.Sc.(P&O) CET- 2024 Objection Redressal

The online Common Entrance Test for post graduate of Physiotherapy, Occupational Therapy, Speech & Language Pathology/Audiology and Prosthetics & Orthotics Courses PGP/ PGO/ M.Sc.(SLP)/M.Sc.(Audio)/ M.Sc. (P&O) CET - 2024 was conducted on Sunday, 01<sup>st</sup> September, 2024 by Competent Authority appointed by Government of Maharashtra.

The Question Papers & Answer Key of the examinations were made available through candidate login from 05/09/2024 to 07/09/2024 and candidates were given opportunity to raise objections if any. After the declaration of Provisional Key, this office has received online objections in PGP / PGO / M.Sc.(SLP)/M.Sc.(Audio)-CET related to Questions and key options. The Commissioner, State CET Cell had appointed subject experts to verify the objections.

With respect to PGP CET - 2024 the subject experts have opined that out of 6 unique objections only One (01) Questions in PGP CET 2024 is non-evaluative/ Invalid. The Competent Authority on the basis of the opinion of the respective subject expert has taken a decision to make this one (01) Question from PGP CET 2024 "Non-evaluative/Invalid" and allot One mark for this Non-evaluative One (01) MCQ to all candidates who appeared PGP CET 2024 examination to the respective subject. The detail of Invalid Question of PGP CET 2024 is shown in **Table No.1**.

The subject experts also opined that there is change in answer key options in one (01) question out of the One objection received for PGO CET 2024. It differs from the Provisional Answer key published on website. This one (01) questions from PGO CET 2024 is correct and hence are evaluative.
