- b) Colleges are required to publish merit lists along with waitlisted candidates by the universities, colleges and other recognized institutes and on the respective college or institute's official website or <https://fn.mahacet.org/> portal.
- c) Acceptance of offered seats from Candidates on the <https://fn.mahacet.org/> portal
- d) Confirmation of offered seat and payment of college fees from Candidates on the <https://fn.mahacet.org/> portal.
- e) Confirmation from Colleges regarding college fees
- f) Intimation to the waitlisted candidates
- g) Acceptance of offered Seat from waitlisted candidates on the <https://fn.mahacet.org/> portal
- h) Confirmation of offered Seat and payment of college fees from waitlisted candidates on the <https://fn.mahacet.org/> portal
- i) Acknowledgment from colleges regarding tuition fees paid by the student on the portal
- j) Candidates are required to report to the college and confirm their admission on or before **04th September 2025, 5:00 PM**, after allotment.
- k) The college must upload and confirm the details of candidates along with their admission status on the <https://fn.mahacet.org/> portal on or before **04th September 2025, 6:00 PM**.
